## **AUTHORIZATION OF CRIMINAL/COURT RECORDS CHECK**

- 1. In connection with my application, I understand an investigative report will be requested; this report will include information as to my character, work habits, performance and experience, along with reasons for disciplinary action or termination of past employment. I understand as directed by policy and consistent with the position described, information may be requested from public and private sources about my criminal record, driving record, education, and previous employment.
- 2. The fact that an applicant has a criminal record will not be an automatic bar of employment or volunteer work, other than convictions involving any type of abuse (sexual, physical, etc) against a minor. Factors such as age at the time of the criminal offense, seriousness and nature of the violation, time elapsed, and subsequent rehabilitation will be taken into account.
- 3. I acknowledge that a fax or photographic copy will be as valid as the original. This release is valid for most federal, state and county agencies.
- 4. I hereby authorize, without reservation, any law enforcement agency, court, institution, information service bureau, school, employer, or other organization or person contacted by MMN and/or ASM or its agent to furnish the information described in the attached request.

Furthermore, I, the undersigned, do for myself, my heirs, executors and administrators, hereby remise, release and forever discharge and agree to indemnify MMN and/or ASM and each of their directors, board members, officers, employees and agents harmless from and against any and all causes of actions, suits, liabilities, costs, debts and sums of money, claims and demands whatsoever, and any and all related attorney's fees, court costs and other expenses resulting from the investigation of my background in connection with my application to become an employee or volunteer of MMN and/or ASM along with any and all affiliates thereof.
